Official Talent Contest Rules

Each contestant must be a resident of Illinois

Junior Division is open to all entries who are not over the age of 14 as of October 1, 2010. Minimum age requirement is 5 years, as of July 13, 2010.

Senior Division is open to all entries who are 15 to 21 years of age as of October 1, 2010.

Contest is limited to 10 contestants in each division. (The first 10 applications received by mail). **ONE ENTRY PER ENVELOPE.**

Performance time limit is 4 minutes. (Exceeding time limit is automatic disqualification)

Contestants may appear in only one act.

All contestants must supply their own equipment, **including piano or keyboard.**

NO CASSETTE TAPES PLEASE

Set-up time limit is three minutes.

No contestant may use back up vocals in his or her accompaniment, unless the voice is their own, recorded, and part of the original composition.

Professional entertainers are not eligible.

Entry must be submitted **BY MAIL**, postmarked no sooner than June 1, 2010, and received no later than July 6, 2010.

Contestants must report to stage area by 6:30 P.M. the night of the contest.

BAND ENTRIES

All band members **MUST** meet age requirements for division in which they are performing

Judges' decisions will be final.

WINNER MUST BE AVAILABLE TO REPRESENT MACOUPIN COUNTY AT THE STATE TALENT CONTEST HELD IN JANUARY, 2011 AT THE STATE CONVENTION OF COUNTY FAIRS, SPRINGFIELD, IL. IF THE WINNER IS UNABLE OR UNWILLING TO ATTEND, THE SECOND PLACE FINISHER WILL THEN BE ELIGIBLE, WITH THE SAME UNDERSTANDING. NO EXCEPTIONS!

Any previous first place winner cannot enter again in the same division

CD player will be available. NO CASSETTE TAPES PLEASE. Piano or
keyboard will not be furnished

Back-up vocals MAY be used in your accompaniment.

Entries must be postmarked no sooner than June 1, 2010 and received
no later than July 6, 2010.

Contestants must report to the stage area by 6:30 P.M. the night of
the contest.

Winner WILL NOT represent the county at the State Talent Contest, as
there is NO ADULT DIVISION at the state level.

This division is open to anyone, of any age, 22 and above, who would
like to showcase their talent, but is ineligible for the other two
divisions.
